The Role

The ideal candidate is someone who has worked on major energy infrastructure projects and is familiar with the UK regulatory regime for offshore wind and other marine infrastructure, with a particular focus on the DCO, Marine Licencing and/or Section 36 process.

You'll be degree qualified in a relevant discipline as well as having a project management qualification from the Association for Project Management or equivalent. You will also possess a good understanding of Environmental Impact Assessment (EIA).

Role and accountabilities

You will work as part of a growing team who have a range of experience across the nuclear, renewables and interconnector sectors.
